Please find below some considerations on the project intention "*Development of the Concept of Open Research Infrastructure SAS for Applied Research in Slovakia*",
17.9 MEUR:

- **P.2, Related types of actions:** it would be useful if this point also reflected the relevant information from the programme, under action 1.1.4 or if it established a clearer connection with the said info
- **Smart specialisation:** According to the ERDF/CF regulation, all investments under specific objective 1.1 need to be in line with the relevant smart specialisation strategy, including the selected smart specialisation areas. The RIS3 2021+ is mentioned several times. However, the project intention would benefit from such connection between intended investments and RIS3 domains made clearer, i.e. by including references to specific relevant actions/measures from the said document as well as the National RDI Strategy and its Action Plan that would be addressed by this project
- **Passporting:** it would be useful if the concept of “passporting” used throughout the document was explained to make it clear what this would entail in the context of the project.
- **Activity 3:** although the most significant activity budget-wise (12.5 MEUR, or ~70% of total allocation), this is the least developed activity in the draft project intention (1 paragraph) and would therefore clearly benefit from more specific information being provided at a much higher level of details, including but not limited to:
 - what type of research infrastructure is meant to be purchased and in what fraction compared to the one to be renewed and replenished?
 - How is the following sentence reflected in the budget “Necessary technical adaptations of laboratories (technical adaptations and fitting-out of premises) shall not exceed one third of the cost of laboratory equipment.”, when the amount allocated to adaptation of laboratories is roughly 50% of that for the research infrastructure?
- Is external personnel going to be employed/needed after the end of project implementation? If so, are the necessary financial resources foreseen to ensure **sustainability** of the project?

I remain available for any clarifications on the above, as needed.
